規 則 Rules & Regulations :

- (一) 申請機構須最少 1 天租用場地。The minimum booking for Event shall be at least 1 day.
- (二) 申請機構只可舉辦已批核之活動。違者特許人有權終止活動。申請機構須即時離場。所付持用費概不發還。Licensee can only hold the event as approved. Failing which, Licensor can terminate the Licence forthwith and the Licensee is required to deliver vacant possession of the venue and the licence fee paid will be forfeited.
- (三) 特許人可給予一天通知取消租場之協定。並只需退回申請機構所繳付之持用費全數 (不付利息)。Licensor has the absolute power and discretion to terminate or revoke the Licence by giving the Licensee a 1 day's notice, and the licence fee will be returned to Licensee without interest by the Licensor.

- (四) 申請機構須於活動日期前購備有關保險，其中必須包括第三者保險；申請機構若損毀場內設備或引致他人受損，將須負責賠償事宜。Licensee undertakes to effect Public Liability insurance cover throughout the Licence Term with a reputable insurance company to the satisfaction of the Licensor. Licensee should be responsible for the damage of facilities of the mall and/or injury caused to any persons during the licence term.
- (五) 於活動期間，所放置物品如有任何由意外引致的損壞或遺失，特許人恕不負責。Licensor will not be responsible for any loss and damage of the products of Licensee during the licence term.
- (六) 不得在租用場內大聲喧嘩或用揚聲器叫賣商品及超出指定範圍，並不得派發傳單。Licensee should not make loud noise, use the loud speaker and distribute leaflet out of the leased boundary.
- (七) 此申請一經批核，申請機構須在通知後十四天內付清持用費及按金並簽妥許用合約，否則將作放棄論。特許人有權將棄權者之場地及展期即時租予其他機構。Licensee should enter the Licence Agreement with the Licensor and pay the licence fee/deposit within 14 days upon the notification from the Licensor. Failing which, the Licensor will assume that the Licensee is no longer interest in licencing the venue and the venue will be offered to other parties without further notice.
- (八) 申請機構須保持場地清潔，並於退場時將所有海報及有關物品清理妥當，及通知商場護衛驗收方可離場。Licensee shall keep the licensed area clean and tidy.
- (九) 申請機構應嚴格遵守商場“活動場地守則”(Annex A)及“置富都會活動場地守則(只適用於申請置富都會展銷場地)”(Annex B)及“預防及控制疾病(規定及指示)(業務及處所)規例關於表列處所的指示”(Annex C)。Licensee must follow the mall “Guideline for using the Exhibition Venue”(Annex A), “Additional Guideline for Fortune Metropolis’ Exhibition Venue (only applied to the Exhibition Venue at Fortune Metropolis) (Annex B)” and “Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation Directions in relation to Schedule Premises (Annex C).
- (十) 申請機構必須自行申請及在活動日當天展示已經申請的「安心出行」二維碼供參與人士使用。特許人不會提供「安心出行」二維碼及不會承擔申請機構任何違反“預防及控制疾病(規定及指示)(業務及處所)規例關於表列處所的指示”所帶來的責任。Licensee must apply and display their own “LeaveAtHome” QR Code for their event. Licensor will not provide any “LeaveAtHome” QR code to the Licensee. Licensor are not responsible for any responsibilities arise from “Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation Directions in relation to Schedule Premises.
- (十一) 特許人免費提供舞台(如有)。參加者需自備表演道具及服裝。有關表演不得收費或包含商業成份。Licensor will provide the stage (if available) free of charge. Licensee should prepare their own props and costumes. Access to the performance should be free of charged and the performance should be of a non-commercial nature. 表演項目、內容、日期及時間需經特許人審核及確認方為有效，表演者須尊重並接受其最終決定。表演一經確實，不得取消或延期。Content, date and time of performance should be approved by the Licensor. Licensee should not cancel or postpone the event once approved by the Licensor.
- (十二) 如有任何爭議，特許人保留所有最終決定權。If there is any dispute, the Licensor reserves the right to make the final decision.
